Independent Agency Response to Public Regulatory Reform Nominations

On December 19, 2002, the Office of Management and Budget (OMB) submitted its annual report to Congress on the costs and benefits of Federal regulations entitled, "Stimulating Smarter Regulation." An important component of this year's report is OMB's response to the statutory requirement to include recommendations for regulatory reform. In our March draft report, we requested public nominations for regulatory reforms. The public was also encouraged to consider problematic paperwork and guidance document requirements, along with regulatory requirements.

In order to encourage broad public participation and to expand on the response to last year's report, OMB also conducted outreach activities to a wide variety of groups. As a result, we received approximately 1,700 public comments nominating specific regulations and guidance documents for reform. Candidates included both suggestions for new or additional regulation and for modification or rescission of existing regulation.

The Office of Information and Regulatory Affairs (OIRA) conducted a preliminary review of the public comments and identified 267 rules and 49 guidance documents nominated for reform by one or more commenters. We excluded from consideration comments that did not provide specific information on regulations or guidance documents.

In our review of the 316 nominations, we found comments on 49 rules and two guidance documents of the following independent agencies: the Equal Employment Opportunity Commission, the Federal Communications Commission, the Federal Energy Regulatory Commission, the Federal Reserve Board, the Federal Trade Commission, and the Securities and Exchange Commission.

We have asked executive branch agencies to review each of the nominations for reform applicable to them (see attached memorandum to the President's Management Council). We will be discussing these nominations with agencies later this winter. For the 49 rules and two guidance documents that are the responsibility of independent agencies, OIRA requests that the responsible agencies consider these public nominations and, for those they consider to be possible candidates for reform, place their evaluations on their websites. The public comments suggesting candidates for reform and OIRA's summaries of them—are available on the OMB website at http://www.whitehouse.gov/omb/inforeg/regpol-reports_congress.html. For your convenience, we are attaching a list of the 49 rules and two guidance documents.

It is OIRA's hope that this review of public nominations by the independent agencies will be objective, consistent, and grounded in the regulatory principles codified in Executive Order 12866 and the statutory authority of the agencies. In conducting this evaluation, we have suggested that agencies rely on three criteria: efficiency, fairness, and practicality.
